**Design, Supply and Installation of Proprietary System Curtain Wall (7th to 14th Floor) of the Proposed Magistrate Courts Complex at Colombo 12

1. The Chairman, Senior Procurement Committee, on behalf of the Central Engineering Services (Private) Limited (CESL), now invites sealed bids from eligible and qualified bidders for the above works.
2. Bid should be submitted on the forms available from the Chief Operation Engineer (P&CM), CESL Head Office, Central Engineering Services (Private) Limited, No. 11, Jawatta Road, Colombo 5 from 22.09.2025 until 16.10.2025 on a payment of non-refundable tender fee of Rs. 12,500.00.
3. The Bidder shall comply with the following eligibility criteria.
 - The successful bidder shall not have been blacklisted.
 - Shall have CIDA registration Grade SP1 or SP2 for Aluminium & Finishes (A&F).
4. The Bidder shall comply with the following qualification criteria.
 - Average of the annual volume of similar work performed in the last five years shall be at least Rs. 50 million
 - The minimum amount of liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payment which may be made under the Contract, shall be not less than Rs. 30 million.
 - The bidder shall have at least five (05) years' experience in supplying, installing and maintenance of similar type or higher scale projects of curtain wall in Sri Lanka and having experience in performing at least one contract of a similar nature, complexity and value equivalent or above to the proposed works over the last 5 years
 - The manufacturer of the proprietary systems shall have at least ten (10) years' experience in the design and manufacture of similar type curtain walls and make of offered curtain wall system and associated accessories shall have at least 5 years proven service records in Sri Lanka
5. To qualify for the Contract Award, the successful Bidder shall possess a valid Certificate issued by the Registrar of Public Contract, in accordance with the Public Contracts Act No. 3 of 1987

10. All bids must be accompanied by a Bid Security of Rs. 600,000.00.
11. Sealed bids may be delivered to the Chief Operation Engineer (P&CM), CESL Head Office, Central Engineering Services (Private) Limited, No. 11, Jawatta Road, Colombo 5.
12. The construction period is 180 Days. (Fabrication – 120 days, Installation – 60 days)
13. The deadline for submission of bids will be 14.00 hrs on 17.10.2025 and will be opened soon after the closing. Bidders or their authorized representatives are requested to be present at the opening of bids.
