Supply, Delivery and Placing of Air-Cooled Chillers for the Accident and Emergency Treatment Unit at Teaching Hospital, Jaffna (Stage II) (BID NO. - CESL/HO/PROC/SPC/176)

1. The Chairman, Senior Procurement Committee (SPC), on behalf of Central Engineering Services (Private) Limited (CESL) invites sealed bids from eligible and qualified local bidders for the Supply, Delivery and Placing of Air-Cooled Chillers for the Accident and Emergency Treatment Unit at Teaching Hospital, Jaffna (Stage II).
The Contract consists of the supply, delivery to site, unloading and placing on the Sixth floor slab, testing and commissioning of 2 numbers of Air Cooled Packaged VFD Screw Chillers having minimum cooling capacity of 90 TR each, for the Accident and Emergency Treatment Unit at Teaching Hospital, Jaffna (Stage II).
2. Bidding will be conducted through National Competitive Bidding procedure.
3. Interested Bidders may obtain further information from the Chief Operation Engineer (P&CM), CESL Head Office, Central Engineering Services (Private) Limited, No. 11, Jawatta Road, Colombo 5 and inspect the Bidding Documents free of charge at the above address from 0900 to 1500 hrs., during normal working days, from 22.09.2025 until 14.10.2025
4. Qualification requirements include;
 - The bidder shall be a reputed local company having experience in supplying of Chillers at least for last 5 years in Sri Lanka.
 - The Bidder shall have experience in supplying of at least 3 numbers of same make, air cooled chillers (one of them shall be 90 TR or above capacity), within last 8 years in Sri Lanka.
 - The manufacturer of the Chiller equipment shall have at least 8 years of experience in the design and manufacture of similar type Chillers.
 - The make of Chiller equipment offered shall have satisfactory proven service record in Sri Lanka at least for last 5 years
 - Average annual turnover of the bidder in the last 3 years shall be at least Rs. 90 million
 - The amount of liquid assets and/or credit facilities available for the bidder is at least Rs. 30 million.Additional details are provided in the Bidding Documents.
6. A complete set of Bidding Documents in English language may be purchased by interested Bidders, on the submission of a written application to the Chief Operation Engineer (P&CM), CESL Head Office, Central Engineering Services (Private) Limited, No. 11, Jawatta Road, Colombo 5, from 22.09.2025 until 14.10.2025 from 0900 to 1500 hrs., during normal working days upon payment of a non-refundable fee of Rs. 15,000.00. The method of payment shall be cash. In the application letter, please nominate a responsible officer with contact details (including email) to communicate during the bidding period. Bids shall be delivered and deposited in the Tender Box provided for, at CESL Head Office, Central Engineering Services (Private) Limited, No. 11, Jawatta Road, Colombo 5, at or before 1400 hrs., on 15.10.2025. Late Bids will be rejected. Bids will be opened soon after closing, in the presence of Bidders' representatives who choose to attend.
8. Bids shall be valid up to 91 days from the Closing of Bids.
9. All bids shall be accompanied by a Bid Security of Rs. 600,000.00
10. A Pre-Bid Meeting will be held at 1100 hrs., on 30.09.2025, at the site of the Accident and Emergency Treatment Unit at Teaching Hospital, Jaffna
