### **Invitation for Bids (IFB)**

#### **Supply and Installation of Piped Medical Gas System for Medical Wards Complex (Phase II) at General Hospital, Kalutara (Procurement Number: CESL/HO/PROC/SPC/185)**

1. The Chairman, Senior Procurement Committee (DPC-Sn), on behalf of Central Engineering Services (Private) Limited now invites sealed Bids from eligible and qualified local Bidders for the Supply and Installation of Piped Medical Gas System for Medical Wards Complex (Phase II) at General Hospital, Kalutara.

The Work mainly consists of design, manufacture, shop testing, delivery to site, erecting, commissioning, site testing, maintaining and handing over the material, equipment plant and services required for Piped Medical Gas system to be installed at Medical Wards Complex at General Hospital, Kalutara. Time for completion is 150 days.

2. Bidding will be conducted through National Competitive Bidding procedure.
3. To be eligible for the Contract Award, the successful Bidder shall not have been blacklisted and shall have CIDA Registration Grade EM2 or above under the category of Medical Gas Systems
4. Qualification requirements to qualify for the Contract Award include
  - The bidder shall be a locally registered company having at least five (5) years' experience in the field of supply, installation and maintenance of Piped Medical Gas systems .
  - The bidder shall have successfully completed the supply and installation of at least three (3) Piped Medical Gas Systems within the last five (5) years in Sri Lanka. Out of these, at least one (1) contract shall have a minimum contract value of LKR 50 million..
  - The average annual turnover of the Bidder for the last 5 years shall be not less than Rs. 100 million.
  - The amount of liquid assets and/or credit facilities available for the bidder is at least Rs. 50 millionAdditional details are provided in the Bidding Documents.
5. To qualify for the Contract Award, the successful Bidder shall possess a valid Certificate issued by the Registrar of Public Contract, in accordance with the Public Contracts Act No. 3 of 1987
6. Interested Bidders may obtain further information from the Chief Operation Engineer (P&CM), CESL Head Office, No. 11, Jawatta Road, Colombo 5, and inspect the Bidding Documents free of charge at the above address from 0900 to 1500 hrs., during normal working days from 18.05.2026 to 08.06.2026.
7. A complete set of Bidding Documents in English language may be purchased by interested Bidders, on the submission of a written application to the Chief Operation Engineer (P&CM), CESL Head Office, No. 11, Jawatta Road, Colombo 5, from 18.05.2026 to 08.06.2026 from 0900 to 1500hrs., during normal working days upon payment of a non-refundable fee of Rs. 15,000.00. The method of payment shall be cash. In the application letter, please nominate an authorized officer with contact details to communicate during the bidding period. 8. Bids shall be delivered and handed over to the Chief Operation Engineer (P&CM), at CESL Head Office, No. 11, Jawatta Road, Colombo 5, at or before 1100 hrs., on 09.06.2026. Late Bids will be rejected. Bids will be opened soon after closing, in the presence of Bidders' representatives who choose to attend.
9. Bids shall be valid up to 91 Days from the deadline for submission of Bids.
10. All Bids shall be accompanied by a Bid Security of Rs. 900,000.00.
11. A Pre-Bid Meeting will be held at 1300 hrs., on 25.05.2026, at the site of the Medical Wards Complex, General Hospital, Kalutara.
