1. The Chairman, Base Procurement Committee, Central Engineering Services (Pvt) Ltd now invites sealed bids from eligible and qualified bidders for Supplying and Installation of Ceiling in 8th, 9th and 10th Floors for the Proposed Head Office Building, Ministry of Health (Bidding No: CL/WP2-J3/PRO-BD279/2026-06) as described below.
Location of Project: No. 106, Dudley Senanayake Mawatha, Colombo 08.
The construction period is 120 days.
2. Bidding will be conducted through National Competitive Bidding Procedure.
3. In order to be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the all following requirements. Foreign bidders are not allowed for the above contract.
 - Bidder shall have at least Five (05) years' experience in Supplying and Installation of Ceiling in Sri Lanka and having qualified technical staff trained for installation of said works.
 - The manufacturer of the Ceiling shall have at least Five (5) year experience in service record in Sri Lanka.
4. Qualification requirement to qualify for contract award include;
 - Average annual value of Supplying and Installation of Ceiling work performed in last five (5) years shall be at least Rs. 30 million.
 - The minimum amount of Liquid Assets or credit facilities required is Rs. 30 million.
5. Interested bidders may obtain further information from the Eng. Uthpala 071 910 4652 and inspect the bidding documents at No11, Jawatta Road, Colombo 05 from 09.00 hrs to 15.00 hrs during normal working hours **from 10.06.2026 until 01.07.2026**

Bidding document in English language may be purchased by interested bidders on the submission of a written application to the account, Central Engineering Services (Pvt) Ltd, No 11, Jawatta Road, Colombo 05 from 09.00 hrs to 15.00 hrs. Upon payment of a non-refundable fee of Rs. 8,000.00. The method of payment shall be cash payment. Only one set of documents will be issued for one bidder.
7. **The Pre-bid meeting will be held on 18.06.2026 at 10.00 hrs** in No. 106, Dudley Senanayake Mawatha, Colombo 08.
8. Bid shall be valid up to 91 days from the date of closing of bids.
9. All bids shall be accompanied by a **Bid Security of Rs. 300,000.00**, which shall be valid for a period of 119 days from the date closing of bids.

Bids shall be addressed to the Chairman, Base Procurement Committee, Central Engineering Services (Pvt) Ltd, No 11, Jawatta Road, Colombo 05, and deposited in the Tender Box Provided at the above address **on or before 11 hrs on 02.07.2026**. Late bids will be rejected. Bids will be opened soon after closing in the presence of bidders' representatives who choose to attend.
