The Chairman, Base Procurement Committee, Central Engineering Services (Pvt) Ltd now invites sealed bids from eligible and qualified bidders for Supply and Fabricate Cement Fibre Partition Panels for the Proposed Head Office Building, Ministry of Health (Bid No. **CL/WP2-J3/PRO-BD279/2026-02**) as described below.  
Location of Project: No. 106, Dudley Senanayake Mawatha, Colombo 08.  
The construction period is **120 days**.
2. Bidding will be conducted through National Competitive Bidding Procedure.
3. In order to be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the all following requirements. Foreign bidders are not allowed for the above contract.
  - Bidder shall have at least **Five (05)** years' experience in Supplying and Fabricating Cement Fibre Partition Panels in Sri Lanka and having qualified technical staff trained for installation of said works.
  - The manufacturer of the Cement Fibre Partitions shall have at least Five (05) year experience in service record in Sri Lanka.
4. Qualification requirement to qualify for contract award include;
  - Average annual value of Supply and Fabricate Cement Fibre Partition Panels work performed in last **five (05)** years shall be at least Rs. 20 **million**.
  - The minimum amount of Liquid Assets or credit facilities required is **Rs. 30 million**.
  - CIDA SP3 or Above

Upon payment of a non-refundable fee of **Rs. 8,000.00**. The method of payment shall be cash payment. Only one set of document will be issued for one bidder.
7. The Pre-bid meeting will be held on 25.02.2026 at 10.00 hrs in No. 106, Dudley Senanayake Mawatha, Colombo 08.
8. Bid shall be **valid up to 91 days** from the date of closing of bids.
9. All bids shall be accompanied by a **Bid Security of Rs. 400,000.00**, which shall be valid for a period of **119 days** from the date closing of bids.

Bids shall be addressed to the Chairman, Base Procurement Committee, Central Engineering Services (Pvt) Ltd, No 11, Jawatta Road, Colombo 05, and deposited in the Tender Box Provided at the above address **on or before 11 hrs on 04.03.2026**.
